

# ***Annual Drinking Water Quality Report for 2018***

### **INTRODUCTION**

This Annual Drinking Water Quality Report for calendar year 2018 is designed to inform you about your drinking water quality. Our goal is to provide you with a safe and dependable supply of drinking water, and we want you to understand the efforts we make to protect your water supply. The quality of your drinking water must meet state and federal requirements administered by the Virginia Department of Health (VDH). ### **GENERAL INFORMATION**

The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally-occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity. Contaminants that may be present in source water include: (1) Microbial contaminants, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations, and wildlife. (2) Inorganic contaminants, such as salts and metals, which can be naturally-occurring or result from urban stormwater runoff, industrial or domestic wastewater discharges, oil and gas production, mining, or farming. (3) Pesticides and herbicides, which may come from a variety of sources such as agriculture, urban stormwater runoff, and residential uses. (4) Organic chemical contaminants, including synthetic and volatile organic chemicals, which are byproducts of industrial processes and petroleum production, and can also come from gas stations, urban stormwater runoff, and septic systems. (5) Radioactive contaminants, which can be naturally-occurring or be the result of oil and gas production and mining activities. In order to ensure that tap water is safe to drink, EPA prescribes regulations which limit the amount of certain contaminants in water provided by public water systems. Food and Drug Administration regulations establish limits for contaminants in bottled water which must provide the same protection for public health.

Drinking water, including bottled drinking water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. Some people may be more vulnerable to contaminants in drinking water than the general population. Immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infections. These people should seek advice about drinking water from their health care providers. ## SOURCES OF YOUR DRINKING WATER

The sources of your drinking water are groundwater and groundwater declared by VDH as under the direct influence of surface water (GUDIS) as described below:

- Wells No. 4, 6 and 8. These groundwater wells pump directly into the distribution system after being chlorinated.
- Wells No. 1, 3 and 5. These GUDIS wells pump directly to the Nickelsville water treatment plant.

Treatment at the Nickelsville water treatment plant is by chemical and physical means including membrane filtration to remove particulate matter and chlorination for disinfection. VDH conducted a source water assessment of the sources in 2002. Well Nos. 1, 3, 4, 5, 6 and 8 were determined to be of high susceptibility to contamination. ## DEFINITIONS

Contaminants in your drinking water are routinely monitored according to Federal and State regulations. The table on the next page shows the results of our monitoring for the period of January 1<sup>st</sup> to December 31<sup>st</sup>, 2018. In the table and elsewhere in this report you will find many terms and abbreviations you might not be familiar with. The following definitions are provided to help you better understand these terms:

*Action Level* - the concentration of a contaminant which, if exceeded, triggers treatment or other requirements that a water system must follow.

*Level 1 assessment* - a study of the water system to identify potential problems and determine (if possible) why total coliform bacteria have been found in our water system.

*Level 2 assessment* - a very detailed study of the waterworks to identify potential problems and determine (if possible) why an *E. coli* PMCL violation has occurred and/or why total coliform bacteria have been found in our water system on multiple occasions.

*Maximum Contaminant Level, or MCL* - the highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.

*Maximum Contaminant Level Goal, or MCLG* - the level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.

*Maximum Residual Disinfectant Level Goal or MRDLG* – the level of drinking water disinfectant below which there is no known or expected risk to health. MRDLGs do not reflect the benefits of the use of disinfectants to control microbial contaminants.

*Maximum Residual Disinfectant Level or MRDL* – the highest level of a disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants.

*Nephelometric Turbidity Unit (NTU)* - nephelometric turbidity unit is a measure of the clarity, or cloudiness, of water. Turbidity in excess of 5 NTU is just noticeable to the average person. Turbidity is monitored because it is a good indicator of the effectiveness of filtration treatment processes.

*Non-detects (ND)* - lab analysis indicates that the contaminant is not present.

*Not Applicable (N.A.)* – there is not a MCLG or an MCL for this particular contaminant.

*Parts per billion (ppb) or Micrograms per liter* - one part per billion corresponds to one minute in 2,000 years, or a single penny in \$10,000,000.

*Parts per million (ppm) or Milligrams per liter (mg/l)* - one part per million corresponds to one minute in two years or a single penny in \$10,000.

*Picocuries per liter (pCi/L)* - Picocuries per liter is a measure of the radioactivity in water.

*Treatment Technique (TT)* - a required process intended to reduce the level of a contaminant in drinking water.

The water quality results in the above tables are from testing done in 2017 and 2018. However, the state allows us to monitor for some contaminants less than once per year because the concentrations of these contaminants do not change frequently. Some of our data, though accurate, is more than one year old.

MCLs are set at very stringent levels by the U.S. Environmental Protection Agency. In developing the standards EPA assumes that the average adult drinks 2 liters of water each day throughout a 70-year life span. EPA generally sets MCLs at levels that will result in no adverse health effects for some contaminants or a one-in-ten-thousand to one-in-a-million chance of having the described health effect for other contaminants.

#### ADDITIONAL INFORMATION FOR LEAD

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. Scott County Public Service Authority is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes or until it becomes cold or reaches a steady temperature before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. ## **VIOLATION INFORMATION**

During the monitoring period of June 1, 2017, to September 30, 2017, we were required to collect ten lead and copper samples from specific homes. We only collected nine of the required samples during this period. We collected 10 lead and copper samples in September, 2018. Results are listed on the 2018 Nickelsville CCR.

During the monitoring period of July 1, 2017, to July 31, 2017, and July 1, 2018, to July 31, 2018, we did not monitor for trihalomethanes and haloacetic acids. We are scheduled to collect samples in July, 2019.

During the first week of April, 2018, we did not monitor for analysis of E. Coli under Round 2 of the Long Term 2 Surface Water Treatment Rule. We have since completed all required monitoring for E. Coli.

During the monitoring period of January 1, 2018, to December 31, 2018, we did not complete all monitoring for combined nitrate and nitrite and therefore cannot be sure of the quality of our drinking water during that time.

State health officials feel there is little need for concern about the safety of your water because past records show that our system has had no documented problems with these contaminants. However routine sampling and analysis are required to determine the quality of water delivered to our customers.
